The Gibraltar boat registration is an international recognized boat registration of the highest class and comes with the Gibraltar AIS & MMSI radio license included. This type of boat registration can be used worldwide without any restrictions. So this means inside and outside of the EU. The Gibraltar boat registration can also be used for commercial boating.

Sailing under the British flag

Gibraltar is a British overseas territory at the south of Spain and contains an area of only 6.7 square kilometer (2.6 square mile). Because it's British overseas territory, registering for the Gibraltar boat registration means you can sail with the highly respected British flag. This also means that your boat is under the protection of the British maritime authorities. Although Gibraltar falls within the British overseas territory, it is not part of the UK.

How does it work?

Do you need a Gibraltar boat registration? Yacht Registration Holland services customers from all over the world. Our registration service covers the whole registration in English. You just need to follow a few steps in our online registration process. When we have received the required original documents, we will submit your request to the Gibraltar maritime authorities. After completion, you will get send your boat registration and AIS & MMSI radio license by overnight courier.

How to arrange your Gibraltar boat registration

Anyone can get a Gibraltar boat registration. It is necessary that the ownership of the boat lies within the UK-Gibraltar. If the ownership of the yacht already lies within the EU or in case of a new yacht and the owner holds an EEA State passport, or a passport from an approved country list (listed below), it's possible to register the Gibraltar yacht registration to your own name.

EEA States:

Austria, Belgium, Bulgaria, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, and Sweden, UK.

The approved countries are:

Argentina, Aruba, Bahrain, Brazil, the Canary Islands, China, the Faroe Islands, Haiti, Israel, Japan, Liberia, Madeira, the Marshall Islands, Monaco, Panama, South Korea, Switzerland, Suriname, and the United Arab Emirates.

I do not have a European passport

When the ownership of the yacht does not lie within the EU and you do not have a European passport, we can set up a dormant UK Limited Company under your name of which you are the only owner. Yacht Registration Holland will arrange the whole process. After we've created your new UK Ltd., we prepare a bill of sale to transfer the ownership of your boat, yacht or jet ski to your new UK Ltd. This way the ownership of your boat now lies within Gibraltar - UK after completion of the registration.

Please note that the company, of which you are the only owner, will not be active and so you do not have to pay any taxes, nor do you have any other formal obligations.

How much does a Gibraltar boat registration cost?

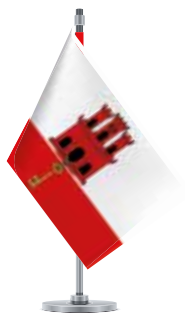

What documents are required for a Gibraltar boat registration?

During the online registration process for a Gibraltar boat registration, we require the following documents:

1. For new boats we need a notarized Builders certificate including data of the name of the initial boat owner.
2. If your boat has an active boat registration or has ever been registered, we need a notarized invoice or bill of sale.
3. If your boat is already sailing under the Gibraltar flag, we just need an invoice.

We also need the following documents:

1. Notarized identification in colour of all owners - including a non notarized color print of the passport / ID card - not older than 3 months
2. Proof of address of all owners
 - a. Copy of the electrical bill, water bill or bank statement not older than 3 months
3. In case of a previous registry, we require a copy of the deletion document
4. Photo of the side and stern of the boat which shows the registration number on it
5. Tonnage certificate provided by an approved surveyor (find an approved boat surveyor)
6. All signed Gibraltar application forms

All original and signed documents should be sent to us by courier. After the registration process we will return all original documents together with the official Gibraltar boat registration documents by overnight courier.
