The compensation is the same for private or company owned vessels.

What documents are needed for a San Marino yacht registration?

To successfully register your yacht in San Marino we need:

1. Color scan copy of your passport or ID card
2. Company documents if the yacht is owned by a company
3. Bill of Sale or Builders Certificate
4. Power of Attorney (we will provide that to you)
5. Proof of deletion of the previous registry (when applicable)
6. Previous International Tonnage Certificate (when available)
7. Completed application forms (we will provide that to you)

All documents need to be in English or Italian or a decent translation needs to be provided.
